

## OFFICIAL RULES AND REGULATIONS

1. No purchase necessary. Void where prohibited. All federal, state and local laws and regulations apply.
2. Must be at least 18-years-old to enter.
3. Contest open to residents of Pennsylvania.
4. The contest period is from November 2 to 2:00 pm Dec. 28, 2009.
5. To enter, go to <http://www.wnep.com> and complete and submit the online entry form. Only one entry per household per week. Entries will be deemed to have been submitted by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
6. ENTRIES MUST BE RECEIVED BY 2:00 p.m. on December 28, 2009.
7. Sponsor(s) will not be responsible for lost, late, forged, mass-reproduced or mass-transmitted, misdirected, mutilated, incomplete or illegible entries and such entries are void; telephone, electronic, hardware or software program, network, Internet or computer malfunctions, failures or difficulties, errors or failures in transmission or reception and/or any condition caused by events beyond the reasonable control of Company which may cause the contest to be disrupted or corrupted.
8. Winners will be determined in random drawings, one per week, from all eligible entries. The decision of the judges is final. The drawings will be held after Noon on November 6, November 13, November 20, November 27, December 4, December 11, December 18 and Monday, December 28. Winners will be notified by e-mail or telephone. Winners must acknowledge the notification either by e-mail or a phone call made to Company at 570-207-2463 by no later than Noon, January 11 or the prize will be forfeited. Company is not responsible for late, misdirected, or unsuccessful efforts to notify prize winners or to acknowledge receipt of notification.
