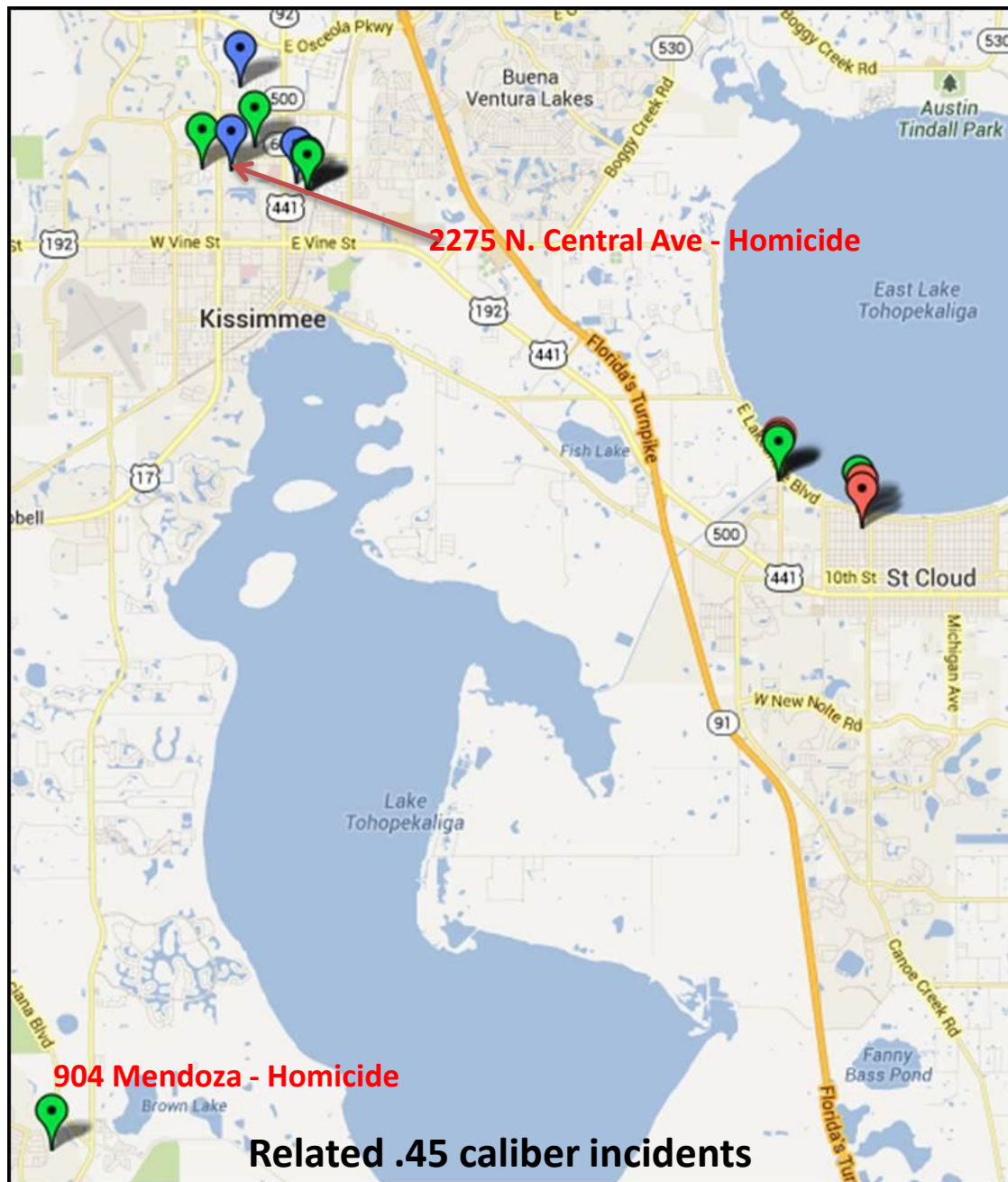

Search for New Evidence

- On July 6, 2013 Kissimmee police detectives and members of the Central Florida Metal Detecting Club and Treasure Coast Archeological Society returned to the scene where David Guerrero was shot.



Search for New Evidence

- A .45 caliber shell casing was recovered. The was processed by FDLE and found to be a ballistics match for other .45 casings found throughout Osceola County, St. Cloud and Kissimmee during the recent shooting incidents.



Gun Identified and Located

The gun was identified as a .45 Hi Point carbine rifle. Detectives, visited gun shops and learned a .45 Hi Point carbine rifle had been sold on 6/24/13 to Lothar Hans Shafer Jr. who was accompanied by his 15 year old son, Konrad Hans Schafer at the time of the transaction. Detectives located Lothar at his home and he confirmed that he owned the rifle and consented to having the weapon processed for ballistics.
